TERMS AND CONDITIONS

1. Subscriber hereby orders from Weather Source, LLC (the “Company”) the items detailed in this Service Order and agrees to pay the Service fee(s) described above by the date due. The Service Fee does not include any taxes, duties, or other governmental charges. The invoice will include any applicable taxes, duties, or other governmental charges that the Company is legally obligated to collect. All payments are non-cancelable and non-refundable.
2. This Service Order is subject to the Weather Source Services Agreement attached to this Service Order and incorporated herein by reference.
3. Unless expressed otherwise in this Service Order, all rights to use the Service will cease upon termination of this Service Order or the Weather Source Services Agreement.
4. This Service Order shall automatically renew on the anniversary of the Initial Term End Date, or any renewal term end date, for successive 12 months terms unless 30 days prior to the end of the then current term, the Subscriber provides written notice to the Company of its intent not to renew. Commencing on the renewal date, and continuing on each anniversary thereafter, the Service Fee may, in the Company’s sole discretion, be adjusted annually (each, an “Adjustment Date”), by an amount equal to any increase in the Consumer Price Index, All-Urban Consumer-All Items (“CPI”) as reported by the U.S Department of Labor on its website at <http://www.bls.gov/cpi>, from a base month of the Effective Date through the Adjustment Date, subject to an annual maximum increase of three (3%) percent. Unless agreed otherwise in writing, the renewal fees shall be invoiced no earlier than 30 days prior to the start of any renewal term with a payment term of net 30.

This Service Order is between the Company and the Subscriber named above and is effective as the Effective Date specified above. If there is a conflict between this Service Order and a provision of the Weather Source Services Agreement, the terms in this Service Order will control.
